

12. Conditional quotation will not be accepted.
13. The Director General, NAC shall reserve the right to reject any or all the quotations without assigning any reason therefor. Director General NAC reserves the right to increase or decrease the quantity.
14. The agency has to issue disposal certificate for the e-waste collected within (15) days to NAC.
15. "Pick and choose" of material will not be allowed and agency should lift the whole lot.
16. The material shall be lifted during working days in between 10:00 AM to 5:00 PM.
17. Total payment for all items at one time shall be made in the form of DD/online in favour of Director General (NAC), Hyderabad and lift the *material* by taking a gate pass from Director(Admin) and the material shall be shifted within (24) hours from receipt of Gate Pass. If the agency has failed to lift the material within stipulated period, NAC will have right to dispose off such accumulated waste material at the risk and cost of agency.
18. The weightment / counting of material will take place in the premises of NAC in presence of authorized representative of the contractor or his nominee.
19. A declaration certificate stating that "All materials allotted to our firm as per sale order will not be mis-utilized in any manner that would affect the Nation's environment on the firm's letter head to be submitted to NAC Hyderabad before lifting the material.
20. The NAC will not make arrangements for weighment, transit insurance etc, such arrangements are to be made by the contractor.
21. All e-waste manual dismantling operations shall be as per the e-waste (management and Handling) Rules, 2011 and as per the CPCB's final guidelines for implementation of the E-WASTE (Management) Rules, 2016.
